Disbursement of monthly pension to the dependents of Late Selvaraj

Employees' State Insurance Corporation is a statutory body constituted under ESI Act, 1948. Any company employed with ten or more persons is coverable under this Act. An employee earning wages up to Rs. 21000 per month is covered under ESI Act and eligible for the benefits available under ESI Scheme.

Late Shri. Selvaraj, was working as a helper at M/s ITC Ltd, Thekkampatty Coimbatore under the contract of K. Devendran & P. Senthilnathan. He was an Insured Person under ESI Act for the past 7 years (From 2017 onwards). On 08.12.2023 while he was working at the loading point at around 4.50 p.m. he started vomiting continuously all of a sudden. After giving First Aid, he was admitted at ESI Hospital Singanallur. On 09.12.2023 at around 5.47 a.m. he expired due to cardiogenic shock.

Since the accident has happened during the course of employment and the deceased was covered under ESI scheme, ESI Corporation admitted the above case as one of the death due to Employment Injury and awarded Dependent Benefit to the family of Late Shri. Selvaraj.

The Insured Person's wife Smt. Amsaveni is eligible for a total pension of Rs. 11774/- per month from ESI Corporation, SRO Coimbatore.

Shri. E. Esakki Siva, Deputy Director of ESI Corporation, Sub Regional Office, Coimbatore and Shri. V. Srirajsivashankar, Branch Manager, Branch Office Mettupalayam handed over the sanction order and payment of Rs. 77840/- (Rupees Seventy Seven Thousand Eight Hundred and Forty only) to the family of Late Shri. Selvaraj on 26.07.2024 at ESIC, Branch Office, Mettupalayam in the presence of Mr. Devendran, Contractor.
