### **AAA+ (Ask An Appointment Mobile App)**

The ESIC 'Ask an Appointment' AAA+ mobile app, available on both Android and iOS, serves insured persons, beneficiaries, staff, and ESI pensioners, and is accessible in 8 languages, including English, Hindi, and six regional languages. Designed to streamline healthcare services, the app allows users to book online appointments, check in without waiting in queues, and access their e-Health records. Over the past two years, new features have been added, such as Aadhaar seeding for beneficiaries, home sample collection requests, and eligibility checks for various ESI benefits. Additionally, prescriptions are prioritized at pharmacy counters, ensuring efficient service for AAA+ appointments.
